kay it's been a slow recess for Congress as they were all on the campaign trails, but there are two things the government is working on. The first one is to pass a National Defense Authorization Act to fund our military, and the Annual Budget to avoid a government shutdown. These are the two main issues as this 117th Congress ends for the holiday and the 118th Congress is sworn in January. PVA believes there are still two important key legislative bills we can get through before this Congress ends. HR 3304 Cars for Vets Act passed the House in late

September. This bill authorizes the Department of Veterans Affairs (VA) to provide (or assist in providing) an eligible veteran or service member

with an additional automobile or other conveyance under the VA automobile allowance and adaptive equipment program. Currently, a veteran or service member with a specified service-connected disability or impairment may not receive more than one automobile or other conveyance under the program. It was presented to the Senate on Oct 10. We believe Congress would try to pass it via a hotline process (requiring no debate). Please call our Senators and let them know how important the bill is to you. The House also passed the Clothing Allowance bill. The bill requires the VA to continue the clothing allowance for such a veteran on an

annual basis until they no longer need it without annual reviews. This bill will also likely be a hotline bill to hopefully get through. Please rush to call the Hill regarding these two key issues. They must hear about it from their con-

stituents, then they're more likely to endorse the bill.

The HCBS bill (Elizabeth Dole Home- and Community-Based Services for Veterans and Caregivers Act of 2022) has not been passed

by either chamber, but

there's a small chance the House could bring it up for a floor vote. An opinion editorial in the Hill newspaper by PVA President Charles Brown and Dole Foundation Executive Director urging Congress to pass the HCBS bill. The bill Increases payments from the Department of Veterans Affairs (VA) for long-term care and support of veterans; encourages VA to expand access to a non-VA provider that would furnish all-inclusive care to elderly veterans living *continued on page 4*

in the community; requires VA to update IT capabilities to assist veterans and caregivers using long-term health care and support services; requires VA to carry out a pilot program that would provide homemaker and health aide services to veterans; requires several reports and studies on departmental programs that provide medical and health services to elderly veterans at home and in the community.

The Justice for ALS Veterans Act and HISA bills discussions have been ongoing, but they are unlikely to advance any further and will need to be reintroduced in the next congress. The VA still hasn't commented on the reforms they're considering regarding caregiver programs. Spouses who are caregivers who cannot work, don't earn credits for SS retirement. This will be addressed again in the 118th. The Administration for Community Living published a national strategy in September and there was a 60-day comment period. The intent was to identify actions federal agencies could commit to doing to support the needs of family caregivers. On November 17th the Subcommittee on Aviation had a hearing on accessible air travel. You can watch the whole hearing on the House Transportation Infrastructure Committee website where you can hear about experiences flying. Many champions are on our side wondering why there are so many challenges in air travel. A webinar on Electric Vehicles was held on November 17th as well. You can watch that webinar on pva.org and share it with your chapter members. There are a lot of webinars available on PVA's website and share them.

The Access Board has taken comments regarding self-service transaction machines and self-service kiosks, including check-in machines, fare machines, ticketing machines, etc. PVA submitted comments for each to be as accessible as possible and preferred the authority be under their board. Additional work is ongoing regarding DOT who has received over 4,000 comments regarding air travelers with disabilities and ticketing.

A team is forming to address several issues once again this winter in Washington D.C. We are trained two days, then have two days to we meet with legislative offices. This work MUST be followed up by your calls, letters and emails for our efforts to be effective.

### **Veterans Affairs Life Insurance (VALIFE)**

here are changes that benefit the veteran, and there are changes that benefit the veteran's loved ones. I would like to bring to your attention some news we can all use, such as; starting January 1, 2023, Public Law 116-315 has authorized the Department of Veterans Affairs (VA) to start a new life insurance program exclusively for disabled veterans – Veterans Affairs Life Insurance (VALife). The Veterans Affairs Life Insurance (VALife) has something that a lot of us wished we had enrolled in long ago. Now after missing out on the Service-Disabled Veterans Life Insurance (S-DVI), we have an opportunity to get it right. I don't know how many times I've heard veterans talk about how they wished they had taken advantage of this insurance.

If you need to ask what is (VALife)? It would probably be answered as, a guaranteed acceptance of whole life insurance coverage that requires no proof of health. The next important question is who is eligible? You are eligible if you are;

- Are aged 80 or under and have a VA disability rating, or
- Applied for VA disability rating before age 81 and received an initial rating after turning 81.

Next, you're probably wondering is there a time limit to apply?

- Age 80 or under, there is no time limit to apply.
- Age 81 or Over: Must apply within two years of receiving a rating for a new service-connected condition applied before the age of 81.

How much coverage can I get? Up to \$40,000 (in increments of \$10,000). Today, it seems as if we are living longer, and Funeral Expenses are getting higher. We all would want our loved ones to be taken care of, at the time of our passing on. You asked when does my coverage take effect? The Full (VALife) coverage takes effect two years after enrollment. Now for those who have been enrolled in the S-DVI, the Impact on Service-Disabled Veterans Insurance (S-DVI), is like this. You may ask what happens to (S-DVI), when (VALife) starts? The service –disabled veterans insurance (S-DVI) programs will close to new enrollment (no new applications will be accepted) after December



31, 2022. Remember that you can apply for (VALife) if you already have (S-DVI)? Also, if you have (S-DV)I, you can apply for (VALife). If you apply before December 31, 2025, you can keep S-DVI during the initial two-year enrollment period for VALife. Do I have to switch to VALife? No, you may remain in the S-DVI program if you chose to.

Remember, that this full coverage amount pays to a receiving beneficiary if the disabled veteran dies within two years of enrollment. Also, it is important to know that these premiums in most cases are much lower than those that are in the community. The VALife premium chart can be viewed at VA.gov/life-Insurance. The premiums rates are based on your age and the coverage amount. Once locked in, premium rates do not increase over the life of the policy. I hope that this information was a benefit to you, as it was for me.



### **PVA VETERANS CAREER PROGRAM UPDATE**

### **Promoting Your Abilities**



Hamilton (Steele) Oliver is a Marine Corps Veteran with a spinal cord injury and 80% service-connected disability rating. He first reached out to the Veterans Career Program (VCP) in October of 2022 with a desire to work in the firearms training industry.

Steele shared his background in firearms training and passion for firearms; but has been faced with self-reported discrimination due to being wheelchair bound. While he attended over 20 interviews over the past year, employers would ultimately "go with someone else". Seeking advice and assistance from VCP, our Vocational Rehabilitation Counselor, Alex Spangler, assisted Steele with different ways to address his disability with employers, and helped the client prepare for interviews in a more creative manner.

Many PVA members regularly participate in competitive shooting tournaments; so, our counselor encouraged Steele to promote his ability to attract new customers (including disabled Veterans) who may otherwise have shied away from this activity.

In less than 2 months, after implementing the assistance provided, the Steele received a job offer from a Richmond, VA gun shop and has since accepted the position. Alex and Steele are now working together to ensure the client's success.
