


The 5th Annual Vaughan Bowling Tournament will be held May 3-5th, 2024, In partnership with the AWBA.








Introduction

As a part of CMU, I held the position of Account Executive for Vaughan PVA, where I managed a team of 3 other account assistants responsible for various aspects of Vaughan PVA's marketing efforts.



new and unique Vaughan PVA website, weekly event-related promotional social media posts, the creation of blog posts, and consistent updates to the website to keep it current. It has been three months now since I have been hired, and I am super excited to continue working for such a great organization with even more incredible people behind the helm.

Short-Term Goals:

The first of the significant short-term goals for Communications is doing final checks on all of the PPC advertising donation pages created to ensure that the chapter's messaging is consistent. After final checks are complete, the four pages will be enabled, and we will then enable the Google Ads we list we have developed utilizing the \$10,000 Google Ads grant.

The second short-term goal is to create additional posts to promote the upcoming bass fishing tournament at Rend Lake to promote the event on a digital scale.

The third short-term goal is wrapping up the National Wheelchair Softball World Series by sharing some of the highlights through pictures captured at the event. A wrap-up video is also in the works of footage that was captured.

The fourth short-term goal is seeking sponsors for the chapter and the sports and recreation events the chapter is hosting. We are always looking for companies and organizations that would benefit our members and will continue to pursue sponsorships and promotions that are in the best interest of our members.

The final short-term goal is to utilize the VPVA Twitter, Instagram, and LinkedIn pages to promote events and content related to the chapter.

Long-Term Goals:

The first long-term goal for my position is the constant monitoring of the Google Ads page for the Vaughan chapter as soon as we enable the Google Ads grant. I will have to review the ads we pay for on a weekly or bi-weekly basis removing keywords that don't receive any clicks and taking note of the keywords that do receive clicks. This would include coming up with new keywords to purchase that are relevant to promoting our chapter, which is beneficial in driving donations to our chapter. Optimizing our Pay-per-click advertising (PPC) will increase the likely hood of an individual clicking on one of the ads our chapter displays which will direct them to our webpage and increase our ability to drive donations.

My primary long-term goal for my position is to research potential businesses willing to sponsor, partner with, or help us fundraise for our chapter. This would involve research into businesses that directly support Veterans, some with charitable giving initiatives, etc. If any businesses would like to engage with the chapter, they would be promoted on the homepage and our social media. Another initiative would be looking for potential Chicagoland businesses to sponsor or partner with us or engage in fundraising through round up campaigns.



Understanding Your Tax Exemption Status in Illinois

Veterans with Disabilities, Specially Adapted Housing, and Homestead Exemption for Persons with Disabilities. These are all the tax exemption programs that impact our clients who suffer from SCI/D.

Which one works for your household? Which one will yield the better benefit? Will your surviving spouse benefit from the tax exemption?

Let's examine

Standard Homestead Exemption for Veterans with Disabilities

Beginning in the tax year 2007 and after, this exemption is an annual reduction in equalized assessed value on the primary residence occupied by a qualified veteran with a disability. This veteran with a disability must own or lease a single-family residence and be liable for payment of property taxes.



The property's total EAV must be less than \$250,000 after subtracting any portion used for commercial purposes. The amount of the exemption depends on the percentage of the service-connected disability as certified by the United States Department of Veterans Affairs. A qualified veteran with a service-connected disability of at least 30% but less than 50% will receive a \$2,500 reduction in EAV; if the veteran has a service-connected disability of 50% but less than 70%, the annual exemption is \$5,000; and if the veteran has a service-connected disability of 70% or more, the residential property is exempt from taxation. NOTE: An unremarried surviving spouse of a veteran who was disabled and is now deceased can continue to receive this exemption on his or her spouse's primary residence, or transfer this exemption to another primary residence after the original primary residence of a veteran with a disability is sold, provided this exemption had previously been granted to the veteran with a disability. The surviving spouse must occupy and hold legal or beneficial title to the primary residence during the assessment year and submit a Form PTAX-342, Application for the Standard Homestead Exemption for Veterans with Disabilities, available from your local assessment office, to transfer this exemption to themselves.

The property cannot receive this exemption for a single tax year and the Veterans with Disabilities Exemption for Specially Adapted Housing or the Homestead Exemption for Persons with Disabilities.

Tax Exemption/Grant Department 217-782-6643

Veterans with Disabilities Exemption for Specially Adapted Housing

This exemption may be up to a \$100,000 reduction on the assessed value for certain types of housing owned and used exclusively be a veteran with a disability in which federal funds have been used for the purchase or construction of specially adapted housing. The exemption is valid for as long as the veteran, the spouse, or the unmarried surviving spouse resides on the property. Federal and staffinancial assistance is provided for service-connected veterans with disabilities to acquire or remodel suitable dwelling units with special fixtures or moveable facilities made necessary by the veteran's permanent and total service-connected disabilities as determined by the U.S. Department of Veterans Affairs.

Beginning with the 2015 tax year, the exemption also applies to housing that is specifically constructed or adapted to suit a qualifying veteran's disability if a charitable organization donates the housing or adaptations and the veteran has been approved to receive funds or the purchase or construction of Specially Adapted Housing through the U.S. Department of Veterans Affairs. This exemption is also available on a mobile home owned and used exclusively by a veteran with a disability or his or her spouse.

The property cannot receive this exemption for a single tax year and the Homestead Exemption for Persons with Disabilities or Standard Homestead Exemption for Veterans with Disabilities. If you would like more information, you can contact 877-827-3702 and select prompt 3. To identify the SAH agent covering Illinois.

I want you to know that tax exemption is a valued financial relief from property taxes; please review the existing benefits you earned them. These tax laws are subject to changes at the State and Federal level. Contact your local Congressional office to ensure these benefits are protected. Contact PVA Legislation representative for changes that impact exemption status and advocacy at the National Level.

Contact your National Service Officer to review your specific eligibility or entitlements regarding the various tax exemption programs. I have attached the link to review all tax programs within the State of Illinois. https://tax.illinois.gov/localgovernments/property/taxrelief.html



Neither can I, so let's let the cat out of the bag and do something with our precious summertime and great weather while it lasts! (Fiscal year 10/1/2022 to 9/10/2023).

RECAPPING MEMBER FUNDS PER FISCAL YEAR:

- 1. Lifetime adjournment fund \$150 per fiscal year: Go to a Movie, take the wife to dinner or a football game, submit your receipts, and the chapter will reimburse you up to \$150:

TAKING A LEAP OF FAITH



Changing career paths can be daunting and complex, yet rewarding when you finally take the leap of faith. Ana Dominguez was seeking a more fulfilling career and contacted PVA's Veterans Career Program to assist her with a career transition in April 2023.

Ana served honorably in the Army National Guard, including a deployment

to Iraq, while completing her bachelor's degree in Business Administration. She began her civilian career in the financial industry as a bank examiner with the FDIC. While her work was rewarding, she found herself feeling unfulfilled and seeking opportunities to serve people, primarily children in need.

In May 2021, Ana was diagnosed with Leukemia/blood cancer which placed her career on hold. She would go on to receive cancer treatments and achieve remission in February 2022. Shortly after, Ana began volunteering her spare time in both family violence prevention and child advocacy services. She enjoyed being an advocate so much, she began thinking about a career change. However, this was also placed on hold when the cancer relapsed in July of the same year. Finally, in October 2022, Ana's cancer would again go into remission and not return.

In early 2023, Ana began working with VCP's Employment Analyst, Rodney Lee. After sharing her compelling story, Rodney conducted research and found job opportunities that matched her volunteerism, background, and skills. After finding a great fit as a Child Protective Investigator trainee, Rodney provided resume tailoring assistance to Ana. Ana would then submit her application for the role, receiving a call to interview and a formal job offer within a week. She accepted her new position and started training with the Texas Department of Family and Protective Services on June 19, 2023.

Since its inception in 2007, the Veterans Career Program (formerly known as PAVE) has placed over 2,923 Veterans (including 435 PVA Members), military spouses and caregivers in meaningful employment, education and volunteer opportunities.




